

PUBLISHING AGREEMENT

This Publishing Agreement is made effective _____ day of _____, 2007 by and between Family Care Solutions, Inc., a nonprofit organization having an address at 1701 W. Lehigh Avenue, Philadelphia, PA 19132 (“Licensee”) and _____, a resident of _____ [City, State] having an address of _____ [ADDRESS] (“Licensor”).

In consideration of the undertakings set forth hereinafter and intending to be legally bound, the parties hereby agree as follows regarding the use of selected materials from Licensor’s work titled _____ in Licensee’s work tentatively titled, “*Professor, Can I bring my Baby to Class?*” on the terms described below:

1. **LICENSED MATERIALS:** This Publishing Agreement applies to the Licensor’s Work as described here: (“the Licensed Materials”) attached as Exhibit A hereto.

2. **LICENSED:** Licensor hereby grants Licensee, and Licensee’s successors, assigns, and sub-licensees, a non-exclusive license to copy, reproduce, print, publish, sell and distribute in bound or unbound editions in print, audio, or electronic forms, at Licensee’s sole cost and expense, the Licensed Materials and any approved revisions thereto. Such grant includes the right to use, transmit, or distribute excerpts and abridgements in all media, in perpetuity and throughout the world.

3. **USE OF LICENSED MATERIALS:** Licensee may edit, condense, or otherwise adapt the Licensed Materials without the prior written permission of Licensor.

4. **MATERIALS:** Licensor agrees to provide Licensee the following materials:

 (a) Documentation about Licensor’s life experiences as a single female parent, over the age of 17, pursuing higher education at an accredited degree granting post-secondary institution

 (b) Short biography of Licensor (no more than 75 words)

5. **REPRESENTATIONS:** Licensor represents and warrants that the representations in the Licensed Materials are true; and that the Licensor is the sole author and proprietor of said Licensed Materials and the sole owner of all the rights granted to Licensee and has full power to enter into this Publishing Agreement. Such representations and warranties include the right for Licensee to request and/or verify any and all information contained in the Licensed Materials, including but not limited to, Licensor’s enrollment and/or graduation status at Licensor’s accredited degree granting post-secondary institution.

6. **ACKNOWLEDGEMENT:** Licensee will acknowledge Licensor as original author of Licensor’s Work and will include a short biographical sketch of Licensor.

7. **COMPENSATION:** In full consideration of all rights, licenses, and privileges granted in this Publishing Agreement, Licensee agrees to pay Licensors as follows: Copy of book to be sent upon publication.

8. **ASSIGNMENT:** Licensee may freely assign, license, sublicense or transfer Licensee's rights under this Agreement, including the rights and releases conveyed by Licensors in this Agreement, to any person or entity without notice to Licensors. All rights conveyed by Licensors apply to Licensee's assigns and/or successors without limitation.

9. **WARRANTIES AND RECIPROCAL INDEMNITY:** Licensors warrants to Licensee that Licensors owns and controls the rights licensed in this Publishing Agreement, and agrees to indemnify and defend Licensee from any claim, loss, or liability arising from breach of the foregoing warranty.

10. **GENERAL PROVISIONS:** This Agreement constitutes the full and complete understanding and agreement of the parties as to the Licensed Material and there are no other understandings or agreements, express, or implied as to the Licensed Material. No modification, amendment, or waiver shall be valid or binding unless made in writing and signed by all parties hereto. This Agreement shall be deemed made in, and is to be construed and interpreted in accordance with the laws of the Commonwealth of Pennsylvania.
